2. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of the releasees or otherwise while in or upon the West Feliciana Sports Park Arena grounds or for any purpose related to the event.

EACH OF THE UNDERSIGNED expressly agrees and acknowledges that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the law of the Louisiana and that if any portion thereof is held invalid, the remainder and balance shall continue in full legal force and effect.
